


Preferential Runway Program Performance Measure:

Preferential Runway Program Performance Measure (For operations between 9PM and 6AM)




Preferential Runway Program Performance Measure explanations

- ATC SPACING (±)2 minutes of aircraft landing on Preferential Runway to allow for ATC spacing needs
- CONSTRUCTION Aircraft used Runway 13L/31R due to a closure of Preferential Runway
- WEIGHT Aircraft exempt from participation since it is a Turboprop aircraft under 12,500 lbs
- MEDICAL Aircraft used runway 13L/31R in the process of responding to a medical emergence
- RAW Runway utilization prior to any adjustments





What information would be interesting to you:




